

**Directions to Show Site:**

**From West:** (From New Buffalo, MI) I-94 to Exit 4A, US 12 East to Bakertown Rd. (approximately five miles east of Galien.) Turn left (north) on Bakertown.

**From North, South & East:** Take US 31 / 20 Bypass to Exit 3, US 12 in Michigan. Go west approximately four miles to Bakertown Rd. Turn right (north) on Bakertown.

**Once on Bakertown Road,** go north one mile to Post Road. The ECHO building and grounds are on the southeast corner of Bakertown and Post Roads.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a vet or judge, or barred from competition by the action of the show committee.

Bitches in season and bitches with an Ovarian Sparing Spay are not permitted to compete. The club will refund the entry fee, less the \$10.00 processing fee, for any competitor who provides a veterinarian's certificate verifying that the female came into season after the pre-entry deadline date for entries. The certificate may be mailed, provided the post-mark is no later than the date prior to the day of the trial or delivered by hand to the Event Secretary before the published start time of the trial. Any bitch excused because she is found to be "so attractive to males as to be a disturbing element" will not receive a refund.

If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fees will be made. Extreme weather conditions, such as but not limited to snowstorms, lighting, tornadoes, or extreme heat must be considered for the health and safety of the dogs, exhibitors, and spectators. In the event it is necessary to cancel or stop the show before completion, no refunds will be made.

UKC and ECHO are not responsible for loss, accidents or theft. Absolutely no alcoholic beverages or unprescribed drugs will be allowed on the grounds, or while participating in the events, or in the building the day of a UKC Licensed Event.

**UKC and ECHO assume no responsibility for any damage or injury sustained by the exhibitors, handlers, or to any of their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians.**

Ribbons will be given for Trial Qualifiers,  
 1<sup>st</sup> through 4<sup>th</sup> Places, and High Combined. Important Information:

- Obedience entries are limited to a MAXIMUM of 15 runs PER TRIAL, both days.
- TOTAL COMBINED judging time – both trials, both judges - is limited to 8 hours per day.
- Shows are held on Eastern (Michigan) time.
- Doors open both days at 7:00 am Eastern (Michigan) time.
- There will be no setup available before the day of show.
- Pre-registration is preferred and will save you money.
- Confirmation emails will be sent to all pre-entered exhibitors.
- Pre-entered dogs must be checked in 30 minutes before the start of their class.
- These events will be held in accordance with the COVID-19 protocols in effect at the time of the trials. Indoor crating may, or may not, be available, so please be aware that you may have to crate in your vehicle.
- **IF** COVID-19 protocols allow indoor crating - to make the best use of building space, the Show Chair may ask you to move your crate to a different location, or to return your dog to your vehicle. Any dog that is not crated **MUST** be on leash, kept out of the walkways, and away from the ring barriers. The Show committee reserves the right to establish the areas that must be kept clear.
- It is your responsibility to clean up after your dog. Anyone not picking up after their dog will be asked to leave. No refunds.
- Lunch break will be determined by the Judges.
- ECHO Club, Inc. reserves the right to refuse any entry.
